Recently, Dr. Arlene Torres, University Dean of Recruitment and Diversity, CUNY, presented an update on Diversity Hiring and Retention at CUNY to the CUNY Faculty Governance Leaders. The Faculty Executive Committee (FEC) is aware of this program of the University to support efforts for the diversity of the faculty. As you are aware the FEC would like to support efforts to diversify the faculty more than it is at present and to retain faculty with diverse backgrounds who enrich our community. To that end the FEC requests learning what, if any, effort has been made by our College to obtain funding from the \$900,000 funding offered by the University and, if it has, what were the proposed uses for that funding?

We thank you for any information that you can offer us on this.

Dean Larios:

I am concerned by your mention of negative actions in the form of recall for members of the Faculty Executive Committee (FEC) in your email below of May 2nd.. Why would you mention such a possibility when you know there are no procedures for such under governance of the College or University? Further, you make no reference to any rule, regulation, bylaw or policy that I or the FEC may have violated let alone any actual evidence that either I or the FEC have acted improperly in any way. You do not offer or refer to any evidence that the FEC has violated any Bylaws or Policies of the Board of Trustees. You do not offer or refer to any evidence that the FEC has violated any Bylaws or Policies of our own college. At most you state that you have been asked if "the FEC involvement rises to the level of 'interference'." You do not indicate in what way such may have occurred.

If you were simply conveying information about reports received from others and no judgment on your own part on the veracity of those reports, you would not report that you have "grave concern". But you do report that you have grave concern which indicates a judgment on your part and you have formed it without offering I or the FEC opportunity to reply to whatever are the reports you have received containing unspecified allegations and charges. I thus must take note that you have reached conclusions without offering an opportunity for those accused to respond to whatever the claims and charges reported to you may have been.

You state that "These questions are of grave concern to me – and I feel it necessary to share this 'climate' with you." Why should there be a grave concern at all? What violations have occurred? What exactly do you mean by "climate" and where does it exist? Further, it is not possible for either I or the FEC to accept your request "take this email under consideration in your future actions" as we have no idea what you are communicating. What actions? When? Where? With whom? In what way improper? Based on what would it be improper in any way?

Further, and most important on the matter of the relation of the FEC to Departments and the question of interference, I note that in the past the FEC has routinely made communications to and about departmental maters and there were no claims of interference. Far from it, the FEC was thanked for its recommendations, advice and information concerning bylaws and policies. The FEC has always had a role to play and it is more than when there is a recall action. It has a role whenever the rights and welfare of faculty are involved. That is our charge.

Here are just some of the past actions of the FEC related to actions with QCC Academic Departments:

Business Department

FEC investigated claims related to an election of a Chairperson and rendered a report to all members of the department. The FEC was even invited to do so by President Call. There was no claim of interference.

Department of Biological Sciences and Geology

We have actual emails from and to members of the Department of Biological Sciences and Geology going back to 2014 concerning department matters and rules and procedures and asking for FEC advice and thanking us for it during the time the department had as its chair Dr. Melvin Gorelick. FEC communications were sent to the ENTIRE DEPARTMENT concerning bylaws on the right of faculty to have a department meeting and with regard to the procedures for elections in a department and the FEC received expressions of gratitude from members of the Department. We received requests in the past from several members including, but not limited to, Dr. Dave Klarberg and Dr. Nidhi Gadura for advice on Bylaws, which we provided, and they thanked us for it. There was no claim of unauthorized interference regarding FEC actions during the time Melvin Gorelick was Chairperson

At this time the FEC received requests from a number of members of this department. We rejected most of them as calling for actions that were not proper for the FEC. We did however send a note to the Department Chairperson concerning department minutes and the faculty bylaws calling for conformity with Robert's Rules of Oder and Dr. Gadura respectfully thanked us for that. This involved an application of QCC Bylaws.

We also received a request regarding the eligibility of Dr. Monica Trujillo for voting and serving as a course coordinator. We refused to take a position on her eligibility and referred the matter to the department for its action. We are pleased to learn that the department has so acted.

Department of Foreign Languages and Literature

Going back to 2015 and 2016 FEC received multiple reports and requests from members of the department. The FEC needed to conduct a recall of a Chairperson and to handle several requests for such with which the FEC did not take action. The FEC made recommendations to President Diane Bova Call on more than one occasion and no one declared it was interference. President Call summoned the FEC and the entire department to a meeting at which the FEC reiterated its recommendation to the President and no one declared it was interference.

Department of Health, Physical Education and Dance

The FEC was notified that there was a deliberate breach of confidentiality of the Department P&B actions by the Chairperson of the Department and that it was intended to and did occasion conflict amongst members of the department. The FEC received signed documents and testimonies and notified the College and issued a report. The FEC was thanked by members of the Department. The College took some action which it believed to be appropriate and no one declared it was interference.

I now request the following information to better understand what you are attempting to communicate:

- All documents relating to any information received by yourself related to the reports you claim were made to you.
- All documents relating to any concerns expressed to you by any faculty members regarding the actions to which you refer in the email you sent on May 2nd 2018.
- All documents relating to anything that led to your having "grave concern".
- All documents relating to anything contributing to what you describe as "this 'climate'".
- All documents relating to anything that describes what might constitute in your meaning "interference".
- All documents of the University or College relating to anything that defines what constitutes "interference".

In this request the term "document" or "documents" is intended to mean any tangible thing, within the custody or control of CUNY or QCC or their attorneys, or agents, upon which any expression, communication or representation that has been recorded by any means. Further note, that the term "relating to" should be construed to mean and include "evidencing", "referring to", "reflecting", "involving", "concerning", "summarizing", "comprising", "constituting", "consisting of", "containing", "mentioning", "showing", "discussing", "alluding to", "memorializing", and "commenting upon".

If you have any questions concerning the information requested, please contact me.

Finally, I believe that I and the FEC have always acted in accord with CUNY Polices and Bylaws and the QCC Governance Plan and Faculty Bylaws and shall continue to do so. If you can provide us with any actual examples of alleged improper action we will certainly review the facts alleged. Until then emails with veiled threats based upon alleged secret information are not proper.

QCC GOVERNANCE PLAN

Article II. D. POWERS OF THE FACULTY

1. The faculty shall be responsible for the academic status, role, rights, obligations, and freedoms of the faculty, and such other matters that may affect the welfare of the faculty consistent with this document. The faculty through its Executive Committee may address communications to the Board of Trustees by the President in some document whether it be a Chancellor's Report or some other report in which the vote must be recorded.

QCC FACULTY BYLAWS

2.2 The Faculty Executive Committee of Queensborough Community College shall be the principal agency of the Faculty in carrying out its Bylaw responsibilities. Any requests for clarifications of meaning and interpretations are to be directed to the Faculty Executive Committee who are the interpreters of its meaning at the College.

6.1 The Faculty shall be responsible for the academic status, role, rights, obligations, and freedoms of the Faculty, and such other matters that may affect the welfare of the Faculty consistent with this document. The Faculty through its Faculty Executive Committee may address communications to the Board of Trustees.

6.5 The Faculty through its Faculty Executive Committee shall have access to all relevant information as it deems necessary for the fulfillment of its responsibilities.

I do not have the liberty to divulge names; persons who have approached me have either asked for confidentiality or have expressed fear of retaliation. I ask, though, that you take this email under consideration in your future actions.
